Note (A):

On 20 December 2013, Mr. Wang Zhong Sheng (“Mr. Wang”) and RHB OSK Securities Hong Kong Limited (the “Placing Agent”) entered into a placing agreement, whereby the Placing Agent has agreed to place, on behalf of Mr. Wang and on a best efforts basis, an aggregate of up to 880,000,000 existing ordinary shares of the Company (the “Placing Shares”) to not less than six placees at a price of HK\$0.092 per Placing Share (the “Placing”).

On the same day, the Company and Mr. Wang entered into a top-up subscription agreement, whereby Mr. Wang has conditionally agreed to subscribe for, and the Company has conditionally agreed to issue and allot, the Subscription Shares (as defined below) at the subscription price of HK\$0.092 per Subscription Share (the “Subscription Agreement”) (the “Subscription”). The number of new shares to be subscribed by Mr. Wang pursuant to the Subscription Agreement shall be equivalent to the number of Placing Shares successfully placed by the Placing Agent under the Placing (the “Subscription Shares”). The Subscription was conditional upon, among other things, 1) the completion of the Placing; and 2) The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) granting the listing of and permission to deal in, the Subscription Shares.

The Placing was completed on 30 December 2013 in accordance with the Placing Agreement and an aggregate of 880,000,000 Placing Shares have been successfully placed. Listing approval from the Stock Exchange has been granted on 24 December 2013 conditional upon, among others, the completion of the Subscription have to take place on or before 3 January 2014. As at 31 December 2013, the Subscription has not yet been completed. For details of the Placing and the Subscription, please refer to the announcement of the Company dated 22 December 2013.

Note (B):

On 22 December 2013, the Company announced that it has proposed to raise not less than approximately HK\$109.2 million and not more than approximately HK\$131.7 million, before expenses, by an open offer of not less than 2,730,867,896 new shares and not more than 3,293,247,896 new shares at the open offer price of HK\$0.04 per Offer Share (the “Offer Share(s)”), on the basis of one Offer Share for every two existing shares held on the record date payable in full upon application (the “Open Offer”). As at 31 December 2013, the Open Offer has not yet been completed.
